

## 2023-2024 Allstar Prep Financial Obligations & Payment Terms

In accordance with the Consumer Protection Act of Ontario, you have the right to cancel a membership within 10 days of completing your contract. To cancel a contract within the cooling off period, you must provide written notice via email to coaches@supremeallstars.com.

After your initial 10 day cooling off period, all fees paid are non-refundable.

HST is applicable to all listed fees.

Payment methods accepted for Memberships include Visa, Mastercard or Direct Deposit from a Chequing Account. Details of your preferred payment method must be provided at the time of registration.

By registering online for a Supreme Cheerleading Allstar Prep Team, you are agreeing to the following terms:

- 1. Your registration fee will be processed at the time of registration and is non-refundable.
- 2. Monthly tuition payments will be processed on the first of each month from September 1, 2023 through May 1, 2024 through iClasspro. These fees include coaching, administration & processing fees, insurance fees, all local (Ontario) competition & event fees, all choreography, Music Fees (Productions & Licensing) and team practices.
- 3. Competition uniforms for Prep teams are the same design as the 2022-2023 season. Competition uniforms for athlete athletes who are new to the Prep program or who require a different size than worn in the previous season must purchase their uniforms through the Supreme Cheerleading online proshop at <a href="https://www.supremecheerleading.com/proshop">https://www.supremecheerleading.com/proshop</a> by the date(s) specified in the 2023-2024 Prep Team Information Package. Uniforms ordered are a FINAL SALE and not eligible for a refund, credit or exchange of any kind.
- 4. Any declined payments will be subject to a \$50 per transaction NSF fee.
- 5. Any failed payment attempts will be tried again 3 days later then the account will be flagged as past due. Accounts must be in good standing. Any athlete whose account is not in good standing will not be permitted to practice or train.
- 6. In the event of a mandated facility closure, team practices will shift to a virtual format the schedule may be altered to accommodate this change in format.
- 7. 30 days written notice to coaches@supremeallstars.com is required to withdraw from a 2023-2024 Prep team. All fees paid are non-refundable. For example, if a family provides written notice requesting their athlete be removed from an Allstar team on January 20th, 2024, they are required to make all scheduled payments until February 19th, 2024.
- 8. Should any provision of this Agreement be determined to be void, invalid, unenforceable or illegal for whatever reason, such provision(s) shall be null and void; provided, however, that the remaining provisions of this Agreement shall be unaffected thereby and shall continue to be valid and enforceable.
